Center for International Research on the Japanese Economy (CIRJE) is a research center dedicated joint research on the Japanese economy and to collect, analyze,

and disseminate economic data in Japan. CIRJE is located in the Graduate School of Economics at the University of Tokyo, and many faculty members do joint research with members of CIRJE. CIRJE undertakes and encourages unbiased economic research among the academic community, public policymakers, and business professionals.

CIRJE's research agenda has encompassed a wide variety of issues that confront our society. We have had many research projects, including comparative studies on Japanese economy, empirical studies of exchange rates, law and economics, economics of the public supply system, issues on insurance and finance, and many other areas.

CIRJE's research projects receive funding from a variety of sources and much of the funding is obtained directly by project members. But we especially acknowledge financial support from the Japan Federation of Housing Organizations thorough professional scrutiny. Over the years, CIRJE has facilitated a lot of interaction with visitors from abroad and fostered international exchanges by hosting international conferences. Because of globalization of the world economy, it is now indispensable to promote collaborations with international scholars to understand our economy from a global perspective. In particular, collaboration with the other East Asian universities or research institutes is our natural choice because of growing economic integration among East Asian countries. Despite its remarkable economic recovery in the early 2000s, East Asia still has many issues to be solved with regard to how to promote the reform of the economic system. It is urgent to step further to promote intensive research collaboration with Asian economists.

In 2008, CIRJE hosted three international conferences with East Asian economists. The first was the meeting of the Asian Shadow Financial Regulatory Committee (ASFRC) which was held at University of Tokyo on July 4 and 5, 2008. The theme was "Accumulation of Foreign Exchange Rate Reserves and the Role of Sovereign Wealth Fund". We discussed the role of Sovereign Wealth Fund (SWF) under excess capital accumulation and explored a solution that may lead to efficient resource allocation in global economy.

The second was a Joint Conference with Association of the Korean Economic Studies (AKES), which was held at Korea University in Seoul on October 21, 2008. The theme was "Fiscal and Monetary Policy

Issues in Korea and Japan". The unprecedented global financial crises have had serious impacts on East Asian economies. Korean Won depreciated dramatically and Japanese stock prices dropped sharply under the worldwide economic crisis. In the meeting, we had intensive discussions on what are desirable fiscal and monetary policies under the financial turmoil in Korea and Japan.

The third was the Joint Conference with Seoul National University (SNU) which was held at SNU in Seoul on November 14, 2008. CIRJE has had annual conference series with Institute of Economic Research in SNU and this was the fifth conference. The theme was "Applications of Economic Theories and Empirics to Global Issues". The East Asian region experienced a serious currency crisis in the late 1990s. The establishment of the architecture of a new financial system seems to be one of the urgent tasks in order to never experience such a currency crisis again. In light of these perspectives, we discussed how to design a desirable economic system and consider the architecture of a new economic system in East Asia.

UNIVERSITY OF TOKYO LONDON SCHOOL OF ECONOMICS CONFERENCE ON ECONOMIC GEOGRAPHY IN HISTRICAL PERSPECTIVES

We held a conference on "Economic Geography in Historical Perspectives" at Faculty of Economics, The University of Tokyo on January 7th, 2009. This is the third meeting of the series of economic history conferences between the University of Tokyo and London School of Economics (LSE), which started in December 2006. This time, we invited three economic history researchers from LSE, financially supported by the Advanced Program in Economics. Besides the people from LSE and the University of Tokyo, we had participants from Tokyo University of Science, Tohoku University and IDE-JETRO. The papers presented and the discussants are as follows.

Spatial economics is one of the fields of economics which have developed most remarkably since the 1990s, and it has been giving an impact on the economic history research. The papers presented are recent studies on historical economic geography and related studies on economic growth. At the conference, we discussed those papers and exchanged ideas about such issues as the methodology for identifying industrial agglomerations, the new estimate on regional GDP and market potential in the nineteenth century Europe, and identification of the mechanisms of agglomeration economy.

A message from Catalonía

I am currently spending my sabbatical leave visiting the Centre de Recerca en Economia Internacional (CREI) at the Universitat Pompeu Fabra in Barcelona Spain. For me the transition to working and living in Barcelona has gone remarkably smoothly. I owe a big thanks to the staff at CIRJE and CREI for their help in handling the logistics of my visit and facilitating my transition.

CREI and CIRJE are both exceptionally well-run organizations with similar objectives. A principal goal of both institutes is to foster international exchange among researchers in economics. The two institutes do this in similar ways – they host visits from a substantial number of short-term and long-term international researchers and host multiple international conferences each year. Ensuring that these core activities go smoothly requires highly skilled multilingual staff. Both institutions have found ways to secure and retain first class staff.

2009 is a particularly important year for both institutes. This summer the University of Tokyo will host the Far East and South Asia Econometric Society Meetings and this summer Universitat Pompeu Fabra will co-host the European Economic Association Meeting and the Econometric Society European Meetings. CIRJE and CREI will play important roles in hosting these conferences.

There are also some distinctions between CIRJE and CREI. CIRJE hosts visitors in all of the major fields of economics. CREI focuses more on research in international economics, macroeconomics and

related areas. Although the scope of research activities supported by CIRJE is broader, it is also a much smaller institute. CREI has a larger budget. It funds ten full-time regular researchers. CIRJE has no regular full-time researchers. CREI also has more staff and about three times as much floor space as CIRJE. The nature of funding is also somewhat different across the two institutes. CIRJE receives funding from the Faculty of Economics and also relies heavily on external grants. CREI receives substantial funding from the Autonomous Community of Catalonia and supplements this with

The biggest distinction between CIRJE and CREI for me though is a personal one. After having hosted many international visitors over the years at CIRJE, it is a welcome change to switch roles and be a CREI visitor!

UT International Program in Economics

In 2010 our department will launch the UT International of the world with a deep understanding of Japanese and Asian Program in Economics. This program will be an integral part of the graduate program in the Graduate School of Economics at the University of Tokyo. Our excellent education program which was once open only to Japanese-speaking students will now also be available to English speaking students. CIRJE is happy to assist in launching this program.

Globalization is creating new challenges and opportunities for Asian Universities. The number of aspiring students fluent in English seeking excellent education abroad used to be low, but now their number is growing. Although some U.S. and European universities offer excellent programs, they focus on issues relevant to economies in their part of the world and their curriculum does not target issues relevant to economies in Japan and Asia. By setting up a graduate program for Englishspeaking students, we are determined to provide leaders-to-be

economies.

Our department has decided to establish a Ph.D. program that has the highest international standards. This is made possible by our faculties who have obtained their Ph.D.s, and held positions, at internationally acclaimed universities and regularly contribute to the best journals in economics. Our department counts seven Fellows of the Econometric Society among our faculty. This is the highest number of any university in Asia. Our program is designed in such a way that students will be able to obtain their degrees without learning any Japanese, though those who wish to learn Japanese are also encouraged to do so.


